RESOLUTION NO. 2021-10 May 19, 2021

RESOLUTION ENJOINING LGUS TO INTENSIFY THE INFORMATION CAMPAIGN FOR ALL 18 YEARS OLD AND ABOVE TO REGISTER FOR THE COVID-19 VACCINATION EITHER THROUGH ONLINE OR THROUGH THE NEAREST RHU

WHEREAS, IATF Resolution No. 95 dated January 21, 2021 approved the Philippine National Deployment and Vaccination Plan for COVID-19 Vaccines (NDVP). The same document highlights the vital role of the LGUs in the success of the National Vaccination Program. It is a national endeavor which seeks to utilize a whole-of-government and whole-of-society approach;

WHEREAS, the DILG issued Memorandum Circular 2021-07 dated January 18, 2021 enjoining the LGUs to prepare their vaccination plans. Specifically, the LGUs are mandated to prepare their risk communication plan, masterlist of priority of eligible vaccinee population, list of designated vaccine centers, cold chain storages and other logistical requirements; master list of human resources and personnel for the program; reorganized EOC dedicated for vaccine concerns, among others;

WHEREAS, DOH-CHD XII reported that as of May 18, 2021, they have inoculated 50,133 individuals from Priority Population Group A1; 21,291 from Priority Population Group A2; and 1,216 from Priority Population Group A3. The slow progress in the implementation of vaccination is attributed to limited number of vaccines deployed to Region XII and the hesitance of many residents to be inoculated because of fear;



- **WHEREAS,** the Body agreed that an intensive information and education campaign efforts should be implemented by the LGUs to influence and gain the support of the eligible population and general public, and consequently achieve herd immunity against COVID-19;
- NOW, THEREFORE, on motion of RD Aristides Concepcion Tan of DOH-CHD XII and seconded by RD Teresita Socorro Ramos of TESDA XII; BE IT RESOLVED, as it is hereby resolved, to Enjoin LGUs To Intensify The Information Campaign For All 18 Years Old And Above To Register For The COVID-19 Vaccination Either Through Online Or Through The Nearest RHU;
- RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-MEID and NTF COVID-19 for their information. The same copy shall be furnished to RIATF-EID XII and RTF COVID-19 XII members for their information, and all Local Government Units of Region XII for their immediate appropriate action.
