RESOLUTION NO. 2020-010

A RESOLUTUON REQUESTING DICT TO INSTALL AN INTERNET CONNECTIVITY TO THE REGIONAL OFFICES OF REGION XII LOCATED AT THE PRIME REGIONAL CENTER, CARPENTER HILL, CITY OF KORONADAL AND OTHER COVID-19 CENTERS IDENTIFIED BY THE LGUS

WHEREAS, the establishment or activation of the Emergency Operation Center and/or COVID-19 Centers by the RLAs and LGUs, respectively, is one mechanism to address the concerns of the pandemic in Region 12;

WHEREAS, with the imposition of the ECQ, the movement of people is limited to essential transactions only. Henceforth, to ensure continuity in the implementation of the programs and projects of the Government by not being infected with the virus, agencies or LGUs Work From Home (WFH) scheme was established. With this, "new normal" scenario, the use of technology is of its heighten demand;

WHEREAS, the RTF COVID-19 and RIATG-EID 12 play critical roles in fighting and preventing the further spreading of the virus by issuing policies and guidelines for the constituents of Region 12. Since the imposition of the ECQ, the Task Force member agencies and LGUs are conducting virtual meetings using various Online Apps such as but not limited to Zoom, GMeet, etc;

WHEREAS, majority of the regional line agencies in Region 12 are located at the Prime Regional Center, Carpenter Hill, City of Koronadal. Ever since, one of the concerns of the regional offices is the intermittent signal of globe and smart, hence slow internet connectivity;



WHEREAS, the DICT is implementing a Free Wi-Fi for All program. This aims to accelerate the Philippine government's efforts in enhancing internet accessibility for Filipinos, and to bridge the growing Digital Divide in the country;

WHEREAS, the Body finds it very important to have an efficient internet connectivity not only during the virtual meetings during the COVID-19 pandemic but in the day-to-day operations of the Regional Line Agencies;

WHEREFORE, on motion of RD Ramos of NEDA XII and duly seconded by PSR Hebrona of RDC XII;

RESOLVE AS IT HEREBY RESOLVED, that the RIATG-EID 12, RTF-COVID 19 and MDM Cluster is **Requesting DICT to install an Internet Connectivity to the Regional Offices of Region XII** located at the Prime Regional Center, Carpenter Hill, City of Koronadal and other COVID-19 Centers identified by the LGUs;

RESOLVED FURTHER, that copies of this Resolution be furnished to the DICT 12, NTC 12, RDC 12, LCEs of Region 12 and members of the Task Forces for their information and appropriate action;
