RESOLUTION NO. 04-2020 Series of 2020

A RESOLUTION INSTITUTIONALIZING THE REGIONAL EMERGENCY OPERATIONS CENTER (EOC)-OCD 12 AS THE RIATG'S CENTRAL FACILITY IN ALL ISSUES, CONCERNS, COORDINATIONS AND DATABANKING RELATED TO COVID-19

WHEREAS, Presidential Proclamation No. 922 Series of 2020 declared the Philippines under the State of Public Health Emergency due to CoVID-19 and called upon all government agencies including local government units to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail the spread of CoVID-19;

WHEREAS, Executive Order No. 168 Series of 2014 provides for the creation of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases in the Philippines;

WHEREAS, pursuant to IATF Resolution No. 14, Regional Inter-Agency Task Groups for the Management of Emerging Infectious Diseases (IATG-MEID) are hereby organized across regions of the country being headed by the Regional Directors of DOH;



WHEREAS, there is a need to harmonize and process the issues, concerns, coordination mechanisms and data in relation to CoVID-19;

WHEREAS, the Emergency Operations Center of the Office of Civil Defense XII, as mandated under Sec. 9 of RA 10121 and NDRRMC Memorandum, has established linkages in times of disasters from the local up to the regional levels and the government agencies;

NOW, WHEREFORE, upon motion of RD Josephine Cabrido-Leysa, CESO III, DILG XII and seconded by RD Alfred Corpus, PRO XII, the Body resolve as it is hereby RESOLVED to INSTITUTIONALIZE THE REGIONAL EMERGENCY OPERATIONS CENTER (EOC)-OCD 12 AS THE RIATG'S CENTRAL FACILITY IN ALL ISSUES, CONCERNS, COORDINATIONS AND DATABANKING RELATED TO COVID-19;

RESOLVE FURTHER that a copy of the said resolution be forwarded to all the Regional IATG Members, Regional Task Force on CoVID-19 through Governor Suharto T. Mangudadatu, and all Local Government Units within the region for their information and reference;
