INVITATION TO BID FOR THE PROVISION OF MANPOWER SERVICES FOR THE DILG REGIONAL OFFICE XII COVERING THE PERIOD FROM JANUARY 1, 2024 TO DECEMBER 31, 2024

1. The **Department of the Interior of Local Government – Region XII** through the National Expenditure Program (NEP) /General Appropriations Act FY 2024 intends to apply the sum of *Seven Hundred Twenty-Nine Thousand Pesos (PHP 729,000.00)* being the ABC to payments under the contract for the **PROVISION OF MANPOWER SERVICES COVERING THE PERIOD FROM JANUARY 1, 2024 TO DECEMBER 31, 2024**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Department of the Interior of Local Government – Region XII** now invites bids for the above Procurement Project. **Services** is required **from January 1, 2024 to December 31, 2024**. Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Department of the Interior of Local Government (DILG) – Region XII** through its **Regional Bids and Awards Committee (RBAC)** from **8:00 AM to 5:00 PM (Monday – Friday) excluding Saturdays, Sundays, and Holidays**.

7. **Bids must be duly received by the BAC Secretariat in TWO (2) SEALED ENVELOPES INDICATING TECHNICAL COMPONENT AND FINANCIAL COMPONENT;**

MANUAL BID SUBMISSION (HARD COPY) AT THE ADDRESS: DILG XII PRIME REGIONAL GOVERNMENT CENTER, BRGY. CARPENTER HILL, KORONADAL CITY AND MUST BE SUBMITTED NOT LATER THAN 10:00A.M. ON DECEMBER 14, 2023 (Thursday). LATE BIDS SHALL NOT BE ACCEPTED.
8. **ALL BIDS MUST BE ACCOMPANIED BY A BID SECURITY IN ANY OF THE ACCEPTABLE FORMS AND IN THE AMOUNT STATED IN ITB CLAUSE 14.**
9. **BID OPENING SHALL BE ON DECEMBER 14, 2023 (Thursday) at 10:00 AM via BLENDED MODE (FACE TO FACE AND VIDEO CONFERENCING). BIDS WILL BE OPENED IN THE PRESENCE OF THE BIDDER OR HIS/HER AUTHORIZED REPRESENTATIVE WHO CHOOSE TO ATTEND THE ACTIVITY.**
10. **The *Department of the Interior and Local Government (DILG) – Region XII* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.**


