DILG XII HOLDS 1ST PCF SUMMIT 2019



DILG XII conducted the 2019 Regional PCF Summit, the first of its kind in the entire country, on April 12, 2019 at EMR Convention Center, Koronadal City to celebrate the socio-economic gains PCF projects have brought into the lives of beneficiary communities and the region as a whole.

"The Region has received a total allocation of Php 294,500,000.00 from the PCF and this has undeniably made significant impact to the lives of everyone in the community" said Josephine Cabrido-Leysa, CESO V, DILG XII Regional Director.

Twenty (20) LGUs were recognized for their outstanding work in the implementation of PCF projects within their respective territorial jurisdictions during the activity which had the theme "Sharing Innovations and Best Practices towards Good Local Governance."

Field Officers assigned in every LGU-awardee were also given special recognition for providing valuable efforts and necessary technical assistance in PCF project implementation.

Guests from the DILG Central Office include Assistant Secretary Esther A. Aldana, CESO II, Director Anna Liza F. Bonagua, CESO III, Dir. Marlo S. Guanzon, LGOO IV Melanie P. Angulo, and LADD Chief Zaldy I. Masangcay.

PCF projects completed benefitting residents

In 2019, ten (10) PCF projects were completed in the provinces of Sultan Kudarat and Cotabato. Five (5) of which are 2017 PCF projects and the other five (5) are 2018 PCF projects. These projects include farm to market roads, local access roads, widening of provincial roads, water projects, landmarks, street lighting, and health facilities and medical equipment. Since the inception of this incentives program, Region 12 LGU awardees received a total of one hundred forty-three (143) PCFs with a total funding of PHP 294,500,000 for the imperiod of one hundred sixty-two (162) sub-projects. One hundred fifty-nine (159) of which were already completed and three (3) others are on-going implementation.

LUPONG TAGAPAMAYAPA INCENTIVES AWARDS

In 2019, the DILG XII has again proven its unwavering commitment to champion barangay justice system which is better known as the Katarungang Pambarangay. Faithful to its mandate, the DILG XII was able to spearhead the organization of Award Committees in different local levels, provide technical and secretariat assistance to such committees, and provide incentives and awards to declared regional winners.



To jumpstart the CY 2019 assessment, the DILG XII hosted the 2019 RAC Reorganization and Reorientation Meeting conducted on March 29, 2019 at DILG XII Conference Room. It was attended by the members of the Regional Award Committee (RAC): Minda J. Tingzon (Regional Trial Court representative), Evangeline Millones (State Prosecutor's Office representative), and Atty. Veronica A. Dondiego (CSO Representative), and DILG XII representatives Ian Jon S. Clemente (LGMED Assistant Division Chief) and Joanne Castre (LTIA Regional Focal Person).

Barangay Poblacion in the Municipality of Tupi, South Cotabato is the country's best Lupon in the 2019 Lupong Tagapamayapa Incentives Awards (LTIA) for 1st-3rd Class Municipality Category. They bagged a total of PHP 350,000 in cash incentives (PHP 50,000 in the Regional Level and PHP 300,000 in the National Level). Notably, they were 1st Runner Up during the 2018 LTIA.

CITIZEN SATISFACTION INDEX SYSTEM (CSIS)

Two CSIS Utilization Conferences were conducted in 2019. In coordination with concerned DILG Provincial Offices and LRIs, the UtiCon for the Municipality of Surallah, South Cotabato was held on March 29, 2019 at EMR Center, Koronadal City and the Municipality of Midsayap, Province of Cotabato on December 20, 2019 at Midsayap Municipal Hall. The Notre Dame of Marbel University (NDMU) was the partner LRI for LGU Surallah and the Southern Christian College (SCC) for LGU Midsayap.

Seven of the region's most reputable local research institutes (LRIs) forged partnerships with DILG XII to conduct the 2019 CSIS. These LRIs were capacitated on April 1-4, 2019 in Zamboanga City: Southern Christian College, Southern Baptist College, Notre Dame of Kidapawan, University of Southern Mindanao – Kabacan, Notre Dame of Dadiangas University, Notre Dame of Marbel University, and Sultan Kudarat State University.

Ten target municipalities received funding for 2019 CSIS program implementation: Malungon, Columbio, Esperanza, Lambayong, Polomolok, Sto.Niño, Kabacan, Magpet, Midsayap, and Mlang.

DILG XII SPEARHEADS DAGYAW 2019 IN SOCCSKSARGEN

The DILG XII in collaboration with partner agencies successfully conducted DAGYAW, the 4th Open Government and Participatory Governance Regional Town Hall Meeting, for the whole of SOCCSKSARGEN on July 25, 2019 at EMR Famville, Koronadal City.

Seven hundred (700) delegates, more or less, representing government agencies, local government units, academic institutions, private entities, the media, youth sector and civil society organizations convened in the said dialogue aimed to empower the public by providing them a platform for engagement with senior government officials to discuss about the priority programs and accomplishments of the Duterte administration.

CORE ADVOCACY CAMPAIGN ACTIVITIES

Two (2) Federalism/CoRe CSO-partners: Hugpong Federal Movement of the Philippines, Inc. (HFMPI) and the MRRD-Federalism Coalition attended the CSO Coalition Building held on November 4, 2019 at Sarangani Highlands, General Santos City to discuss fundamental features of the thrust for constitutional reform by Prof. Alfred Sureta, a CoRe National Head.

One hundred (100) Sangguniang Kabataan (SK) and Liga ng mga Barangay (LnB) Presidents participated in the Constitutional Advocacy Campaign held on November 5-6, 2019 at Sarangani Highlands, General Santos City.

Hon. Dulia Sultan, LnB Regional President, was also present and expressed eagerness to forge formal linkages in order to strengthen stakeholder relationships and convergence among partner institutions and organizations.

One hundred seven (107) youth leaders gather for the 2019 Youth Congress on November 21-22, 2019 at Villa Amor Hotel, Koronadal City. Composed of Sangguniang Kabataan Officials, local youth leaders, and students, the participants gained insights on Constitutional Reform for the Youth by the renowned political analyst and national CoRe speaker, Prof. Ramon Casiple.

Fifty-four (54) C/MLGOOs were briefed on answers to frequently asked questions and confusions in the grassroots about the shift from Federalism to Constitutional Reform during the Constitutional Reform One-Messaging on December 12, 2019 at The Farm, Koronadal City. Mechanisms and budgetary requirements on Citizen's Awareness Survey were also discussed. Prof. Eric de Torres was the resource speaker during the activity.

SUPPORT TO ANTI-ILLEGAL DRUGS IMPLEMENTATION ACTIVITIES

Strengthening Anti-Illegal Drugs Councils

The proliferation of illegal drug use in our communities has been identified as one serious threat to public health, well-being, and national security. It puts an overarching limit, especially among the youth, on reaching full potentials for development and fuels the propagation of criminalities and other socio-economic challenges.

With these in mind, the DILG XII has maintained the fulfilment of its forefront role in the fight against illegal drugs in the Region. Supportive of the thrusts of the national government, the DILG XII has ensured minimum standard functionality and effectiveness of local anti-drug abuse councils (ADACs) at all geopolitical levels, harmonized their inter-operability, put in place systematic and effective ADAC monitoring and reporting mechanism, and steadfastly assisted local ADACs in meeting set performance indicators of a functional ADAC.

The numbers show that the DILG XII managed to further strengthen the functionality of BADACS. In 2019, to further such efforts, a "Training-cum-Orientation on the Barangay Drug-Clearing Program and BADAC Functionality Indicators" was conducted on April 29-30 in Koronadal City.



This one-on-one coaching was designed to eliminate low functionality scores among BADACs in the Region. One hundred twenty six (126) individuals composed of Punong Barangays and Sangguniang Barangay members representing ninety-two (92) low functional BADACs across the region were present.

The Provincial Local Government Unit of Sultan Kudarat and four (4) of its component municipalities – Columbio, Lutayan, Esperanza, and Senator Ninoy Aguino - all scored 100% in the 2018 ADAC Performance Audit.

President Duterte signed Executive Order No. 70 which institutionalized a Whole-of-Nation (WNA) Approach in dealing with insurgency through the creation of National Task Force to End Local Communist Armed Conflict (NTF-ELCAC). As outlined in the ELCAC-NTF JMC No. 1, Series of 2019, it aims to address the root causes of insurgencies, internal disturbances and tensions, and other armed conflicts and threats.

The Regional Task Force to End Local Communist Armed Conflict (RTF-ELCAC) for SOCCSKSARGEN has remained steadfast in fast tracking the operationalization of EO 70 in this side of the country. Organized on July 4, 2019 through Joint Resolution No. 2, Series of 2019 of the Regional Development Council and Regional Peace and Order Council, it has translated the National Plan ELCAC and its 12 Lines of Efforts (LOEs) into regional and local sectoral objectives.

The twelve (12) LOEs are Situational Awareness and Knowledge Management; Local Government Empowerment; Legal Cooperation; Strategic Communication; Sectoral Unification, Capacity-building and Empowerment; Basic Services; Poverty Reduction, Livelihood and Employment; Infrastructure, Resource Management and Employment; Local Peace Engagement; Peace, Law Enforcement and Development Support; E-CLIP and Amnesty Program; and International Engagement. In 2019, four (4) of these LOEs are led by the DILG.



The government sets forth its full commitment and priorities to end local insurgency in the country through the National Plan to End Local Communist Armed Conflict (NP-ELCAC) as the President signed Executive Order No. 70.

E-CLIP AND AMNESTY PROGRAM

Co-leading with the Department of National Defense (DND), the DILG XII assisted in the continuous implementation of government reintegration programs for the former rebels (FRs) and their families. The provision of immediate livelihood assistance and firearms remuneration for the FRs from Sarangani, Sultan Kudarat, and Cotabato Province were some of the humble accomplishments for 2019. In addition, there are ongoing constructions of half way houses in the four (4) provinces of the region.

In 2019, one hundred fifty-nine (159) FRs in the region are being monitored. One hundred fourteen (114) of them received complete assistance package. Assistance for forty-five of them are still on process. As of October 22, 2019, the assistance extended to them has already amounted to Php 7.288 million.

Status of E-Clip in the Province of Sultan Kudarat

The DILG had allocated PhP 5 million for the establishment of the halfway houses for E-Clip implementation for the 90 former rebels. It was already turned-over to the Provincial Government on November 26, 2019. The Operations Manual in the management of the said institutions are being finalized.

DILG XII STAGES FIRST REGIONAL BARANGAY SUMMIT ON ENDING LOCAL COMMUNIST ARMED CONFLICT (ELCAC)

Numerous Barangay Officials and Punong Barangays of Communist-Terrorist Groups (CTG)-affected communities in Region XII, members of Retooled Community Support Program (RCSP) Teams of different LGUs, and members of the Regional Task Force (RTF) -ELCAC of Region XII convened on December 19, 2019 at The Farm @ Carpenter Hill, Koronadal City. Executive Order No. 70, Series of 2018, or the "Institutionalization of Whole-of-Nation Approach in Attaining Inclusive and Sustainable Peace, Creating a National Task Force to End Local Communist Armed Conflict (ELCAC)" was discussed extensively.

Reynaldo S. Tamayo, Jr., South Cotabato Governor, delivered an earnest welcome message to the participants. He underscored that "progress will never come if peace and order issues are not resolved."



DILG Undersecretary for Local Government Mavel C. Sacendoncillo, CESO II, who also graced the event was impressed by the strong convergent ties between various stakeholders in addressing problems on insurgency and in rebuilding the accessibility of government services even in geographically isolated and disadvantaged areas of the Region.

Balmes addressed and provided clarifications on their GAD- related concerns, misconceptions, and difficulties on GAD Plan and Budget (GPB) formulation and utilization of local GAD fund.



DILG XII AMIDST 2019 MINDANAO EARTHQUAKE

October of 2019 will go down in the history of Mindanao as one with the most destructive series of earthquakes: October 16, 7:37 PM Philippine Standard Time (PST) at magnitude 6.3, on October 29, 9:04 AM and 10:42 AM at magnitudes 6.6 and 6.1, respectively, and on October 31, 9:11 AM at magnitude 6.5.

Around forty thousand infrastructures were ruined most of which are houses, schools, and health facilities. As of December 23, 2019, the disaster tallied 22 deaths, 9 missing and 320 injured. Families displaced inside evacuation centers were 5, 676 and 14, 569 outside.

The towns of Makilala and Tulunan and Kidapawan City, all in the Province of Cotabato experienced most of the destructive geologic impacts. Surrounding municipalities which are low-lying and water-saturated areas were not spared from the resulting damages.

Fuelled by steadfast leadership, DILG XII, being NDRRMC Vice Chairperson for Disaster Preparedness, was able to extend assistance to severely-hit communities through the following efforts:

- Deployed personnel to man the Regional Coordinating Center which facilitates and provides technical support to local Incident Management Teams, timely disseminates policy issuances to the LGUs on matters raised by the response agencies and RDRRMC, and channelling of incident reports.
- RD Leysa, met with local chief executives of Kidapawan City and the municipalities of Makilala, Tulunan, and Mlang on November 2, 2019 in order to gather first-hand information and assess areas for assistance.
- RD Leysa also did an ocular visit town-by-town and also visited Incident Command Posts (ICPs) together with Ma. Theresa D. Bautista (LGCDD Chief/DRR RFP), Arthur P. Condes (Regional Information Officer), DILG Provincial Director Ali B. Abdullah, and concerned DILG Field Officers.
- RD Leysa also discussed with various relief distribution and response teams on how to streamline communication, assistance and coordination with various agencies.
- Assisted in coming up with a mechanism for the smooth inflow and outflow of donated goods received from various sources to the Provincial Emergency Operation Center.
- LGOO IV Jessilou L. Frugalidad assisted in the conduct of Post Disaster Needs Assessment (PDNA) conducted by PDRRMO of the Province of Cotabato.

Institutionalization and mobilization of DILG XII Mindanao Quake Relief and Assistance Drive (MQ-RAD)

- a. DILG XII MQ-RAD's "One Malong, One Family Campaign" was able to raise and distribute more than a thousand malongs to affected residents.
- b. DILG XII MQ-RAD's "One Malong, One Family Campaign" was able to raise and distribute more than a thousand malongs to affected residents.
- c. Pooling of donations from local officials of unaffected LGUs in the Region and other DILG Regional Offices across the country.
- d. Received and facilitated the distribution of cash and relief items from Cabatuan LGU Multi-purpose Cooperative (CLGUMPC) of the Municipality of Cabatuan, Iloilo Province which were personally handed by LGU Cabatuan Mayor Ronilo O. Caspe to RD Leysa.
- e. Distribution of twenty-five (25) tents received from the Bank of the Philippine Islands (BPI) Foundation through the initiative of Captain Dominador Bernales, Vice President and Chief Security Officer of BPI. Such tents were used as temporary shelters of benefitting families who lost their homes.
- f. DILG XII volunteer employees assisted the Barangay Local Government Unit of Carpenter Hill, Koronadal City in repacking rice donations to be delivered to earthquake-hit areas.

DILG XII was humbled to have received commendations from the Local Government Units of the Province of Cotabato and the Municipality of Tulunan. These LGUs passed Sanggunian Resolutions No. 957-5 and No. 269 respectively. Both Resolutions commend DILG XII for assisting in the relief operations and for extending appropriate interventions to earthquake victims in their jurisdictions.
