We continue to commit for peace and order and public safety as we continuously strengthen our drive towards positive peace in the region while developing our communities to become more business-friendly for local and foreign investors.



TRAINING OF TRAINORS FOR THE CAPACITY Development Roll-Out on the Quasi-Judicial

functions of the Local Sanggunia

With the thrust of the department in promoting accountable, participative, and effective local governance, the Bantay Korapsyon Program (BKP) initiated capacity development interventions anchored in its education strategy. One of which is the Strengthening the Knowledge and Capacity of the Local Sanggunian's Quasi-Judicial (QJ) Functions through the conduct of training among Sanggunian Members of target LGUs. To further enhance the initiative, a training module was develope.

To further develop the training module, the BK Central Office and Regional Operations Unit (BKP-ROUs), along with the Bureau of Local Government Supervision—Local Government Relations Division (BLGS - LGRD) conducted the Training of Trainors (TOT) on 24-28 October 2022 at Greenleaf Hotel, General Santos City which was attended by ninety-two (92) participants comprising of personnel from BK-PMO, BLGS -LGRD, and BKP - ROUs from the sixteen participating regions nationwide.



The said training commenced with the overview discussion of the objectives and topics to be discussed in the threeday lecture delivered by Atty. Michelle Anne Vieio, DILG XII Legal Officer. She highlighted the mandates of the Bantay-Korapsyon Program for the Sustainable Development Goal of reducing corruption in all forms, and ensuring clean and efficient governance. One of the initiatives of the BKP is strengthening the knowledge of the Local Sanggunians on the scope of their quasi-judicial powers in order to encourage LGUs to bring to citizens' attention that filing of complaints against erring elective officials can already be processed and managed at the local levels.

It was followed by the discussions on revisiting the Local Sanggunian's Structure and Composition by Atty. Junine Wednesday Java of DILG Region VI. She presented the powers and functions of the Local Sanggunian and distinguished its legislative and quasi-judicial functions in consonance with the provisions of the Local Government Code (LGC). She then enumerated the composition of the different levels of the Sanggunians (Panlalawigan, Panlungsod, and Bayan).





Afterward, Atty Michelle Anne Viejo gave an in depth discussion of the differing aspects of the jurisdiction of the quasi-judicial functions of the local sanggunian. In line with this, she explained the requirements and procedural processess in administrative proceedings in handling of complaints by the sanggunians.

DILG XII holds Pasidungog sa Dose Season 2 - A Regional Awarding **Ceremony for Outstanding LGUs in PPAs Implementation**



The Department of the Interior and Local Government XII through the Office of the Regional Director- Legal Unit led by Atty. Michelle Anne P. Viejo, has conducted the training on "Reinforcing Public Accountability of Local Government Units and Civil Society Organizations through Citizen Participation" on November 15, 2022 at Paraiso Verde, Koronadal City South Cotabato.

41 Online attendees

60 Physical attendees

16 of those were coming from various LGUs while 21 were CSO/ CSDO members.





Present-day challenges of promoting and ensuring human rights in relation to Civil Society Organization initiatives were also accentuated such as the lack of collective means to fully internalize and implement RBA themselves and disconnectedness from the grassroots level.

Meanwhile, in the afternoon session, Atty. Michelle Viejo heated the discussion on RA 3019 or the Anti-Graft and Corrupt Practices Act where she emphasized certain acts that are identified to be corrupt practices under Section 3 and are, therefore, punishable by law.

On top of that, she elaborated the concept of unexplained wealth and encouraged the participants, especially those in the government office to tend their duties rightfully and responsibly file their respective SALNs.

Moreover, Atty. Prima Jesusa Quinsayas-Mangelen, the Deputy Regional Prosecutor of the Department of Justice-Regional Prosecution Office XII delivered the third and final session on "The Crimes and Felonies Committed by Public Officers under the Revised Penal Code".

Finally, Atty. Viejo concluded the training by highlighting the event's main objective which is to produce CSOs and LGUs who are equally knowledgeable, effective, and capable of policing and combatting graft and corruption in public service.

A complaint against any municipal elective official cannot be made arbitrarily unless it is substantiated by legal documentation and facts. It is crucial that we become familiar with the grounds for disciplinary procedures as stipulated in the Local Government Code.

The two-day event held on December 6-7, 2022 aims to heighten the understanding of the Local Sanggunians with regard to their power and functions as quasi-judicial bodies and to capacitate them to effectively perform within the prescribed period of existing laws in the process of receipt, handling, commencement of an administrative investigation, and resolution of complaints filed before their respective Sanggunians.

The training consists of six (6) learning sessions starting with the Getting to Know You Session facilitated by Mr. Relmie Tamson, MLGOO of DILG President Quirino where participants were tasked to convey their expectations for the trainer, the training, and their peers, by writing it on each meta card provided by the secretariat.

That is how DILG XII Regional Director Josephine Cabrido-Leysa, CESO III described the formal launching and signing of the Memorandum of Agreement (MOA) for the institutionalization of the CSO Academy of Soccsksargen at Greenleaf Hotel, Gen. Santos City on April 11.

Considered to be the first learning institution in the country created purposely to "capacitate civil society organization (CSO) leaders", the MOA signing and launching ceremony was held with the presence of all the partners involved in the collaborative efforts, namely; DILG XII, DBM XII, Mahintana Foundation, Inc. (MFI) and the Association of Foundations (AF).


The Tatag ng Agila (Capacity Development Leadership Award) under the Capacity Development Awards for Catalysts of Excellence (CapDev ACE) of the Local Government Academy is 'conferred to the Regional Director whose exceptional leadership led to the delivery of quality, strategic, and responsive capacity development interventions to LGUs' divided into four criteria for judging which include: leadership, innovativeness and creativity, achievement, and inclusiveness.

Back in 2021, RD Leysa had been included in the list of topnotchers as she championed Collaborative Governance, ensuring excellent results and professionalism in leading the performance of DILG XII's nexus.

Meanwhile, MLGOO Marife C. Tenorio was named as 2022 Singsing ng Tanikala (Outstanding MLGOO) in the country under the same program. This award is given to a city or municipal LGOO "who has assisted and influenced LGUs in achieving progress and good local governance" and who has "helped introduce reforms, and continuously influences localities' perspective and practice of good local governance," the Local Government Academy said.

The following are its criteria for judging: high work standards, initiative and innovativeness, and consistency of performance.

This year, DILG XII's Local Governance Regional Resource Center (LGRRC) was also picked as one of the Top 5 finalists under the Ugnay ng Mamamayan (Most Outstanding LGRRC) category of the Program, which gives recognition to the LGRRC team who "has introduced or sustained practical, cost effective initiatives to create a positive and substantial impact on capacity development."












REGION DOSE'S 4TH DAGYAW TOWN HALL MEETING TACKLES GOVERNMENT PROGRAMS & SERVICES

The DILG XII held the 4th DAGYAW Open Government Virtual Town Hall Meeting on November 28, 2022 via Zoom and FB Live, covering various programs for the communities in Region XII. Resource Persons from National Government Agencies presented various programs and services which are readily accessible to the general public.



RD Josephine Cabrido-Leysa, CESO III, Regional Director of DILG XII, welcomed the participants who joined via the Zoom platform and Facebook Live and she emphasized Dagyaw's main objective which is "to strengthen the mutual trust between the government and its people". She encouraged everyone to use the activity as an opportunity to raise guestions about the topics presented.

The Universal Health Care Act or RA 11223 was also thoroughly discussed. The resource person emphasized that the general objective of the law is to ensure equitable access to quality and affordable health care and protection against financial risk and to progressively realize universal health care through systemic approach and clear role delineation. The speaker also highlighted that "basic health services will be free", but for fees beyond the basics, every Filipino family's health spending will be predictable.



The discussion on RA 10354 or the Responsible Parenthood and Reproductive Health Law focuses on the roles of LGUs and different agencies in the provision of care. The resource person for this topic clarified that, for one, "the LGUs, with assistance from the DOH, shall ensure the provision, at the appropriate level of care, of the full range of responsible parenthood and reproductive health care services and that such services will also be readily accessible for PWDs.



The activity was closed by Atty. Libertine Cagang-Guanzon of the DBM XII and she highlighted the importance of social accountability in achieving good governance.

The ongoing campaign to deconstruct private armed groups in Mindanao stems from President Duterte's Executive Order 79 and the normalization process under the Comprehensive Agreement on the Bangsamoro (CAB), which was signed in 2014 by the Government of the Philippines (GPH) and the Moro Islamic Liberation Front (MILF).

The PCVE- PMO Team was led by Ms. Joan Hope Tolibas, the Program Manager, and she was joined by PDO II -PCVE Freddie Rick O.Calos, Supervising Project Officer Katherine R. Derit, Office of the Presidential Adviser on Peace, Reconciliation and Unity (OPAPRU) PDO Vincent B. Parreñas and PCol. Richard B. Verceles from the PNP National Headquarters.

The DILG-led NTF DPAGS have set a meeting on January 2023 to finalize the Implementing Rules and Regulations (IRR) about the program, after taking into consideration all of the consolidated recommendations during the regional roll-outs and DPAG Capdevs for NEOs which were conducted in 17 regions of the country.

Capacity Development Agenda Review

The DILG XII, through the Local Government Capability Development Division (LGCDD) in partnership with the Local Government Academy (LGA) conducted the two-day Capacity Development Agenda Review for the Local Government Units of Tupi, Tboli, Columbio, Lambayong, Bagumbayan, Matalam, Makilala, President Roxas, Kiamba and Glan on December 13-14, 2022 at The Farm @ Carpenter Hill, City of Koronadal, South Cotabato.



The activity was participated by select LGU officials and functionaries with their C/MLGOOs, DILG Outcome and Program Managers, Provincial Focal Persons, and LRIs.

The CapDev Agenda Review aims to revisit the existing CDA of the ten (10) identified LGUs and evaluate the quality of their CDA in accordance to the CDA formulation process and to gather data as to the status of the CDA of the target LGUs to identify necessary CapDev interventions by the CDA regional and provincial coaches to the LGU stakeholders and monitoring and evaluation of the implementation of their CDA.



DILG XII Regional Director Josephine Cabrido-Leysa CESO III, represented by Atty. Michelle Anne P. Viejo, Chief of Staff, DILG Regional Office said "Your Capacity Development Agenda which addresses the needs of the six capacity pillars namely Competency, Structure, Knowledge and Learning, Management System, Enabling Policies, and Leadership, is an important component of your Comprehensive Development Plan that would help you to strategically plan for the development of your capacity to effectively deliver your mandated functions and responsive services."



LGOO V, Mary Eulen Y. Abdilah, Regional CapDev Focal Person discussed the Rationale and Objectives of the Activity. The Overview of the LGU CapDev Framework and Agenda and CapDev Agenda Formulation Step 1: Context Analysis was also presented by Ms. Abdilah wherein the importance of Causal Loop Diagram (CLD) in identifying the factors that contribute to the LGU's performance was given emphasis.

Usually, a building inspection comes after the evacuation of personnel from the office building to check for possible damages but this time, identifying the nearest exit and evacuation area nearest from the training venue to secure the participants was the main priority. The said drill emphasized the importance of preparedness of the personnel not only in a normal day at the office but also during the conduct of trainings outside the office.



The Office of the Civil Defense (OCD) and the National Disaster Risk Reduction and Management Council spearheaded the conduct of the activity to promote preparedness and resilience in times of disasters.

BAGS ITS FIRST SEAL OF GOOD LOCAL GOVERNANCE AWARD

The Province of Sultan Kudarat bagged the first SGLG Award in the recently concluded awarding ceremony at The Manila Hotel last December 15, 2022 together with the LGUs of Bagumbayan, Columbio, Lutayan and Tacurong City. The SGLG is the highest award conferred by the DILG to the LGUs pursuant to Republic Act No. 11292 also known as the SGLG Act of 2019 that institutionalizes the Seal of Good Local Governance award as a tool that promotes transparency, efficiency and good governance among Local Government Units.

The said local government units were assessed based on the 10 governance areas such as financial administration; disaster preparedness; social protection; health compliance and responsiveness; sustainable education; business friendliness and competitiveness; environmental management; safety and peace and order; tourism, heritage development, culture and the arts; and youth and development. The LGUs must pass the 10 governance areas to qualify for SGLG National Awards.

SGLG awardees will receive an Incentive Fund amounting to 5 million for municipalities, 7 million for cities and 9.5 million for provinces under the Performance Challenge Fund which will be a great help to the LGUs in providing timely and responsive projects to its constituents.

TWISTS AND TURNS IN LIFE: SOME THINGS ARE JUST MEANT TO BE

That is the long-and-short of Inecita Cartagena-Kionisala's journey to 34 years of public service, an adventure that is really worth it, despite the momentary setbacks and difficult times she encountered along the way. Over all, she says, it has been a fulfilling, satisfying journey.

Inez, or Ma'am Ging, as she is fondly called, was born in Mlang, Cotabato province back in January 6, 1968. She finished her elementary at Lanao Central Elementary School in 1980 and high school education at Notre Dame of Kidapawan for Girls in 1984. She took up BS-Accounting at Ateneo de Davao University and completed her course in 1988. "Right after graduation, I applied as a Disbursing Officer at the DILG Provincial Office in Kidapawan City after hearing the announcement over the radio," Ynez relates.

"Nobody told me or guided me how to apply but I just took a shot," she recalls. In 1989, she officially started her career in the Department as a Disbursing Officer. She stayed in such position for four (4) years and then she got promoted as LGOO II.

HARDSHIPS HELP SHAPE CHARACTER

During her 10th year in service, she received her LGOO V assignment in LGU-Arakan. "That was back in 1999 till 2000 and you know how difficult things were. Imagine the worst scenario for unpaved roads. Basically, these roads which connect to the hinterland communities were a little more than animal trails, with thick vegetation on both sides," Ma'am Ynez adds. Overall, as she describes it, "the package comes with mud holes during the rainy season and endless clouds of dust when summer comes. And that is what I faced every day as I went to work."

Of course, she did not mention about the threats from armed lawless elements which operated in some of the areas she visited. She is thankful, however, that she had always been safe despite her exposure. "Looking back, it has helped me develop the right attitude: being grateful at all times," Ma'am Ging muttered. Travels to the barangays were really difficult but "seeing how the community grew by leaps and bounds make me say it was worth being there.""

After her stint in Arakan, she returned to the Provincial Office as Section Chief, a post she held onto for 12 years. This position has exposed and tempered her in preparation for her Kidapawan City assignment, which she considered to be 'demanding and quite taxing, in terms of time and office management.' In all the three LGUs she has served as field officer, she got the support of the local officials, department heads and personnel. "Overall, life wasn't that difficult for me," she recounts.

However, she would recall her unnerving experience while in Kidapawan City, something which built her up as well: For three days (from March 30, 2016), farmers' groups and their supporters, numbering by the thousands, blockaded the Davao—Cotabato Road in Kidapawan City. A day prior to the blockade, 500 farmers protested in front of the National Food Authority (NFA) Office in Kidapawan to air their grievances. On April 1, 2016, at around 10:30 AM, police operatives led by Sr. Supt. Alexander Tagum, along with personnel from the Department of Social Welfare and Development conducted operations to clear the highway where the protesters were stationed and started dispersing the crowd. The purpose was to do a 'clearing operation' and 'to rescue minors' who participated in the protests against the provincial government under the leadership of Gov. Emmylou Taliño—Mendoza. The minors were reportedly used as human shield by the protesters, alleged to be members of the Kilusang Magbubukid ng Pilipinas. In the ensuing dispersal which turned violent, there were at least three deaths among the protesters and a "total of 116 injured on both sides after the police dispersed" the protesters.

Her accounting degree landed her a good job at the Department, to say the least, but the lure of working abroad once visited Ma'am Ging. She took up a nursing course on weekends and she was able to finish it, eventually passing the Nursing Board Exam in 2009. "It was the proverbial 'greener pasture' that motivated me to take on a second degree. During that time, licensed nurses earned so much and almost every parent sent their children to nursing schools," she fondly reveals. But that opportunity never came for her as she would continue her work with the Department.

As the Outcome Manager for DILG-Cotabato Province, she has to travel a lot as she does supervisory function over field officers. She shares the burden of some of the MLGOOs since they are also facing a lot of challenges in their own truf, like having no LGU-provided staff. Another problem is the fast turn-over of DILG staff who are assigned to the MLGOOs. "If these personnel think they don't have the chance of getting appointed to plantilla positions, they leave quickly, which is understandable," Ma'am Ging stated.
