This initiative is anchored on the Local Governance Regional Resource Center (LGRRC) XII's platform of DILG Rehiyon Dose that promotes a culture of learning, inter-local cooperation, and partnership among stakeholders in local governance. LGRRC XII intends to install another TV set at the arrival area of the airport in the near future.

With the construction, expansion and repair almost done, Gensan International Airport can now accommodate two million passengers annually, from a low of 800,000 in the previous years. "We have chosen Gensan International Airport because we have seen higher post pandemic foot traffic, with the normalization of travel," Director Leysa said.





CSOs from the different parts of the region participated in the first episode of Dagyaw 2023 Open Government Town Hall Meeting on June 30, 2023 in Koronadal City. Participants aired their sentiments, raised their concerns and gave suggestions in co-opting CSOs in the development process. OIC Asst. Regional Director Romel Patrick E. Tanghal of NEDA XII, as the townhall reporter, presented the Philippine Development Plan 2023-2028, Regional Development Plan, and the participation of CSOs in planning and local governance.

Meanwhile, Mr. Ryan S. Vidanes, Executive Director of Conrado & Ladislawa Alcantara Foundation, Inc. gave his insights on the topic as one of the reactors. He said that CSOs and NGOs are all part of the development sector. For CSOs, "we have to be the voice of the sector we are representing". He continued to elaborate on, CSOs agenda which should be aligned with the priorities of the government, integrate it with sectoral on working advocacies and focus towards regional development, while LGUs should create an enabling environment for CSOs, not just as compliance to DILG directives, but also as appreciation to the contribution of different organizations, as partners for development.





RD Akmad J. Usman, CESO III, in his closing remarks, highlighted the importance of the Dagyaw as an opportunity to gather inputs from the people on a certain matter. He commended the management team and looked forward to another episode of Dagyaw as a follow through to the recently concluded episode.



DILG XII hosts Capacity Program for CSOs in Local Development Council through its Capacity Development Division. It was conducted last April 25, 2023, at Paraiso Verde, Koronadal City. The activity was attended by about 40 CSOs from 16 LGUs in the region. The training course aims to capacitate newly appointed CSO Representatives in the LDC to effectively perform their roles and functions. The training provided participants with the basic knowledge and skills needed to participate actively in LDC activities and advocate sustainable development in the Council.



Participants eagerly shared their experiences and concerns as they participate in the workshop. DILG XII Regional Director Josephine Cabrido-Leysa, CESO III in her message highlighted the purpose of the CSO Academy as "one of the innovations of the region in capacitating the CSOs to become effective & efficient partners of the government." She also emphasized that it is her personal aspiration to witness the thriving and sustained cooperation between the CSOs and the government in delivering services to the community.



Meanwhile, CSO Representatives to the Local School Boards of 16 LGUs in the region actively participated during the Capacity Development Program intended for them held at Paraiso Verde Hotel and Resort, Koronadal City last April 26, 2023.



Regional Director Josephine Cabrido-Leysa, CESO III, in her message, encouraged everyone to "gain knowledge and raise clarifications regarding their roles and responsibilities in the LScB." She also emphasized that the main goal of the activity is to capacitate the CSOs who are sitting as members of the special bodies for them to advocate certain programs and cooperate with their respective LGUs in the process of implementing those programs.



The training has six modules focusing on the reinvention of the LScBs and how the CSOs can contribute to its improvement. Most of the participants were "first timers" in the LScB of their LGUs, making the training vital for them. They also raised concerns on the functionality of their LScBs and their participation in the meetings. During the action planning, the participants proposed programs and activities that they think will address said concerns. The output of the training was CSOs action plan on furthering LScBs for their LGUs.

Financial Assistance to LGUs (FALGU) is one of the five program funds under the Local Government Support Fund (LGSF) which grants financial subsidy to

priority programs and projects of LGUs not funded out of national government agencies or local government budgets. Under Special Provision (SP) No. 3 of the Local Government Support Fund Financial Assistance (LGSFFA) to Local Government Units (LGUs) of Republic Act (RA) No. 11518, or the FY 2021 General Appropriations Act (GAA), the appropriated amount of Php13, 585,219,000.00 shall be used for financial assistance to LGUs, except for those under the Bangsamoro, Autonomous Region in Muslim Mindanao, to support the priority programs and projects.

On top of that, the team conducted Technical Assistance to LGUs on the LGSF -FALGU guidelines and registration using Digital Request Submission for Local Government Support Fund to ensure excellence in Local Governance.

The team has provided various technical assistance (TA) to LGUs of Kiamba, Maasim, Maitum, Malapatan, Sto. Niño, Tantangan, T'boli, and Norala in May 2023. They also provided TA to LGU Polomolok on Non-Infrastructure Projects on May 18, 2023.

The team also assisted in the Updating of SubayBAYAN portal report to help Indigent Individuals as they process the following:

a) Medical; b) Burial; c) Transportation; d) Food Assistance; e)Cash for Work; and f) Educational Assistance and g) Assistance Programs and Projects for Health and Social Protection (in light of the COVID-19 Pandemic). Additionally, other issues like non geotagged photos and lacking attachments/documents were also given attention. In collaboration with the respective Municipal Engineering Offices of the aforementioned MLGUs, the team has provided assistance on the encoding and submission of data in the Subaybayan portal, as well as reoriented the guidelines on FALGU.



The DILG's SubayBAYAN portal, provides details as to the status of locally-funded projects of the department, as well as LGU infrastructure projects - informing the citizenry of the updates of the government projects.



# DILG XII extends oversight, monitoring and evaluation support to DTI's RAPID Growth Project

The DILG XII, through a MOA with DTI XII, commits to support in monitoring and evaluating the implementation of Farm-to-Market Infrastructure projects of the Rapid Growth Project .The Rural Agro-Enterprise Partnership for Inclusive Development (RAPID) Growth Project of DTI is a five-year project funded by

the International Fund for Agricultural Development (IFAD) and it aims to stimulate agro-enterprise development in rural areas. Anchored on selected Value Chains, it adopts a whole-of-government approach in the delivery of services, expands economic opportunities, creates more agro-

enterprises, particularly in the rural areas, and facilitates easy access to market, and technology transfer, financing, and other business development support services.

The Regional and Provincial Technical Engineers, conducted Site Validation, Inspection and Project Documentation of the following FMR Projects:

 Concreting of NHJ Paghidaet -Maligaya (Kadi FMR) in Brgy. Kadi, Senator Ninoy Aquino, Province of Sultan Kudarat on April 14, 2023 ;
Concreting of Road from Calagumet-Calucob Farm to Market Road in Brgy. Sapu Masla, Province of Sarangani on April 11, 2023;
Concreting of Poblacion-Datu Agod Farm to Market Road in Brgy. Datu Agod, Antipas, Province of Cotabato on April 12, 2023;
Concreting of Sitio Bacalto to Sitio Mission Farm-to -Market Road, Barangay Sto. Niño, Bagumbayan, Province of Sultan Kudarat on April 19, 2023;
The two (2) additional Proposed Farm to Market Roads in the municipality of Matalam and Alamada, Cotabato Province on June 15 and 16, 2023.

Subsequently, the team interviewed the key officials involved in the project implementation and the project beneficiaries on their expectations and the impacts of the project especially on their economic and social growth.





PDMU Chief Engr. Herminia S. Ontoy and RAPID focal Person attended the regular Regional Technical Working Group (RTWG) meeting along with the RTWG Member Agencies, namely; DPWH XII, DOST XII, DENR XII, DA XII, DAR XII, and NEDA XII. To further fast-track the preparation of the technical documents of LGUs and to commence the procurement for FY 2023, the team also attended the First Batch training for the 5day Farm-to-Market Infrastructure (FMI) Technical Documents Coaching/Cliniquing Session at the Waterfront Insular Hotel in Davao City on May 22-26, 2023.

The coaching session was conducted by the RAPID National Project Coordination Office (NPCO) and the International Fund for Agricultural Development (IFAD), PDMU XII Chief Engr. Ontoy and Engr. Kriszle Evardoni represented Rehiyon Dose.

All technical documents of the recipient LGUs were presented and reviewed by National Project Coordination Office (NPCO), International Fund for Agricultural Development (IFAD), and DILG to ensure that these are ready for the "No Objection No. 1 Issuance". A workshop followed purposely for the review of the documents.

#### DILG Rehiyon Dose inks partnership with Mindanao State University - General Santos City for the Citizen Satisfaction Index System (CSIS)

DILG Rehiyon Dose and Mindanao State University – General Santos City formally signed the Memorandum of Agreement (MOA), adding another significant milestone in the strategic partnership for the implementation of the CSIS program. Citizen Satisfaction Index System (CSIS) aims to contribute to the vision of the department that all local government units (LGUs), will become self-reliant,

development- centered, safe, peaceful, socially protective, business-friendly, environmentally protective as well as transparent, accountable, and participative. In scaling up local government performance in these areas, the department moves beyond excellence in the internal capacities of LGUs and upgrades to working on their capacities on how to effectively respond to the needs of the citizens who are the end users of the local services.

The Citizen Satisfaction Index System is a set of data tools designed to collect and generate relevant citizens' feedback on the local government's service delivery performance and on the citizens' general satisfaction. It uses a mix of quantitative and qualitative research methods through face-to-face interviews with residents, randomly sampled from barangays of the target LGU.

For CY 2023-2028 the target LGUs are all Highly Urbanized Cities (HUC), comprising 12 HUCs across the country. For Region XII, we will have the LGU of General Santos City. One of the CSIS program partner implementers is the Local Resource Institutes (LRIs). Data gathering and interpreting



esults will be performed by them because of their technical expertise in managing and conducting research. They are deemed to be politically neutral and effective in building rapport with citizens from different socio-demographic backgrounds. Since 2014, MSU General Santos City has already been an LRI partner in the implementation of the CSIS program covering the LGUs of Kiamba, General Santos City, and Koronadal City.



Josephine Cabrido-Leysa, CESO III, Regional Director signed the MOA on behalf of DILG XII and JD. Usman D. Aragasi, MPA, Acting Chancellor signed for MSU - Gensan. Also in attendance during the event were DILG XII ARD Lailyn A. Ortiz, CESO V; DILG Gensan CD. Rilimin H. Sandoval; LGMED Chief, Musarapha A. Alim, MPA; HUC Focal Person Rommelyn A. Damasco; VC for Academic Affairs. Dr. Mishell D. Lawas; VC for Research, Extension, and Innovation Dr. Jaime A. Namocatcat; VC for Planning and Development Prof. Sheila J. Loable; VC for Admin and Finance Ms. Nurleila G. Canacan, MPA; Extension Director Dr. Keno Jay M. Balogbog; Research Director Dr. Christine Dawn G. Obemio; Office of International Affairs Director. Prof. Beverly T. Garcia; University Registrar Prof. Tersa I. Castillo; Project Manager Prof. Berlita Disca; other staff from the DILG, and the rest of the faculty and staff from MSU-General Santos.



The Department of the Interior and Local Government as head of the Executive Committee in the implementation of the National Action Plan on Preventing and Countering Violent Extremism (NAP-PCVE) and the lead agency in the implementation of the NAP on Chemical, Biological, Radiological, and Nuclear (CBRN), in coordination with the DPCVE partner agencies: the PNP, AFP, NICA and partner funding institution, the UNDP, conducted the Regional Rollout to 180 barangays regionwide. Part of its preparation was the conduct of the Localized NAP-PCVE Module Roll-out Training in the Barangays for CY 2023 last May 24-25, 2023 in Koronadal City, South Cotabato.



The activity was graced by DILG XII Regional Director Josephine Cabrido-Leysa, CESO III. In her message, she warmly welcomed and thanked all the participants for their attendance to the Module Rollout. She acknowledged the efforts and support of the barangay officials in the implementation of the NAP-PCVE Module in this region. She then requested the participants to be involved and be serious in their workshop proper because their outputs will serve as the

basis of the PMO and higher LGUs in developing appropriate interventions on the security issues of their areas of responsibilities. She also highlighted the importance of converging the efforts of all stakeholders in peace and security so we can move towards the development aspect of our society.

The participants of the 2-day activity were Punong Barangays, Sangguniang Barangay Members (BPOC Chairpersons), and Chief Tanods of the target barangays in Region 12. The Barangay Assembly serves as the platform for discussion of the barangay officials and their constituents of the issues concerning, but not limited to, social services, peace and order, public safety, disaster risk reduction and management, environmental management, and economic growth and development. A State of Barangay Address (SOBA) shall be delivered highlighting the accomplishments, financial report, plans, projects, and newly-enacted ordinances, among others.



# POC and ADAC Audit 2023



The Department of the Interior and Local Government (DILG) holds an annual performance audit to all Anti-Drug Abuse Councils (ADACs) of provincial, city, and municipal levels across the country. This audit ensures the persistent involvement and effectiveness of local government units in the battle against illegal

drugs. As chairperson of the Anti-Drug Abuse Council Audit Team, DILG brings together the ADAC Provincial Audit Teams (APT) and ADAC Regional Audit Teams (ART) for the audit process. Tasked with assisting component cities and municipalities, the APT, and the ART, which focus on provinces and highly urbanized cities, are composed of representatives from the Philippine Drug Enforcement Agency (PDEA), Philippine National Police (PNP), and civil society organizations (CSOs). Guided by DILG Memorandum Circular 2023-062 and the DILG – DDB Joint Memorandum Circular 2018-01, local ADACs are audited based on defined indicators of functionality and effectiveness.

During the performance audit held in Koronadal City on June 16, 2023, several PADACs underwent a comprehensive evaluation by the ART. These included the councils from Cotabato, Sarangani, South Cotabato, Sultan Kudarat and the CADAC of General Santos City was also assessed. Criteria included the organization of local ADACs, conduct of quarterly meetings, allocation of funds for anti-drug activities within the Peace and Order and Public Safety (POPS) Plan, implementation of ADAC plans and programs, support for component LGUs, and innovation.



Prior to the regional audit in June, a series of provincial audits took place in May 2023. These assessments were spearheaded by the Provincial Audit Teams (APT). Each APT is composed of provincial representatives from the DILG, PNP, PDEA, and two accredited CSO members. These teams carried out audits in the cities and municipalities within the 4 provinces of Region 12.



As we press forward in our collective fight against illegal drugs, these audits serve as a critical tool for evaluating our progress, acknowledging our successes, and identifying areas in need of enhancement. They form an integral part of our shared commitment to building a drug-free Region XII and ultimately, a drug-free Philippines.

# **R12 Inter-Agency Monitoring Task Force concludes the CY 2023 LCAT-VAWC functionality assessment**

The Regional Inter-Agency Monitoring Task Force (RIMT), DILG Provincial and HUC Focal Persons, and select LCAT-VAWC secretariat converge on April 18, 2023 at DILG XII, Koronadal City for the Post Assessment of the CY 2023 Functionality Assessment of the Provincial/HUC Committee on Anti-Trafficking and Violence Against Women and Their Children.



In this meeting, the Provincial IMTs and CIACAT-VAWC Secretariat discussed their implementation status, final results, and issues or concerns on the assessment that was conducted last April 12-14,2023 to the four (4) Provinces and one (1) Highly Urbanized City of the Region.



LGOO II Kimberly T. Tuanzon presented the commendable final ratings of the Provinces and HUC on the concluded assessment. All of the four provinces of Region 12 garnered the score of 80-102%, which is considered as the "IDEAL" Level of Functionality, while HUC Gensan garnered the score of 57-79% which is considered as "MATURE" Level of Functionality.

Pursuant to DILG Memorandum Circular No. 2020-006, this functionality assessment is conducted annually to the Local Committees on Anti-Trafficking and VAWC (LCAT-VAWC). It aims to coordinate and monitor the implementation of Republic Act No. 9208 (Anti-Trafficking in Persons Act of 2003) and Republic Act No. 9262 (Anti-Violence Against Women and their Children Act of 2004). The four areas of concern are the Organization, Meetings, Policies, Plans and Budget, and the Accomplishments of the committee.



Meanwhile, DILG-DSWD-DOJ JMC No. 2010-01 provides the guidelines in the creation of the IMTs who will conduct the assessment and are composed of the representatives from the Department of the Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD), Department of Justice (DOJ), Department of Health (DOH), Philippine National Police (PNP) and a representative from non-government organization partner.

# CFLGA RIMTF XII TABLE VALIDATION

May 16, 2023



The Child-friendly Local Governance Audit (CFLGA) Regional Inter-Agency Monitoring Task Force (RIMTF) from Department of Social Welfare and Development (DSWD XII), National Economic and Development Authority (NEDA XII), Department of Education (DEPED XII), Department of Health (DOH XII), National Nutrition Council (NNC XII) and Save the Children conducted the CFLGA Table Validation last May 16, 2023, via Zoom Platform. The calibration activity was conducted to validate and verify Means of Verification that were uploaded to the web portal for submission of compilation of the reports to the national level. These reports are further examined by the national IMTF.

The Child Friendly Local Governance Audit (CFLGA) is used to evaluate how effective local governments are in promoting and defending the rights and general welfare of children. It tries to assess how far local governments have gone in putting child-friendly laws, initiatives, and services into place.



Local governments may find gaps and opportunities for development, create action plans, and track advancement over time by performing a Child Friendly Local Governance Audit. By properly integrating children's rights into local development plans and procedures, this assures that children's opportunities and well-being within the community will be improved.

### TRAINING ON REENGINEERING OF LGU SYSTEMS AND PROCEDURES FOR PROVINCES

The Department of the Interior and Local Government (DILG) XII, through the Local Government Capability Development Division (LGCDD), in coordination with the Bureau of Local Government Development (BLGD) and the Anti-Red Tape Authority (ARTA) conducted the Training on Reengineering of LGU Systems and Procedures for the Provincial Committee Anti-Red on Tape /Regulatory Reform Team (CART/RRT) members, on May 30-31, 2023 at the Paraiso Verde Hotel and Resort, City of Koronadal, South Cotabato.



The training served as an avenue to help local government units (LGUs) in the region to comply with the requirements under Section 5 of Republic Act No. 11032, otherwise known as Ease-of-Doing Business and Efficient Government Service Delivery (EODB-EGSD) Act of 2018 and its Implementing Rules and Regulations (IRR). In general, improving the LGU Competitiveness and Ease-of-Doing Business (EODB) aims to enhance the local business environment for economic recovery, facilitate more investments, and generate more jobs by improving regulatory services and public services among LGUs, creating local enabling environment to encourage local investments, and encourage private sector investments in public sector infrastructure and services toward local economic development.

DILG XII Regional Director Josephine Cabrido-Leysa CESO III emphasized the importance of "Digital Strategy in improving the LGUs service delivery and to reduce the bureaucratic red tape and processing time."





The resource persons for the training came from DILG-BLGD Central Office, Anti-Red Tape Authority and the DILG Provincial/City EODB Focal Persons. Twenty-eight active provincial CART/RRT members from the four provinces of Region XII attended the activity and they are expected to review their LGU's systems and procedures and undergo evaluation and improvement of their transactions. If necessary, they need to reengineer the same to reduce bureaucratic red tape and processing time, in accordance with the provisions of ARTA on EODB-EGSD Act at their levels.

### DILG REHIYON DOSE HOLDS TRAINING ON THE FORMULATION OF THE LOCAL INVESTMENT AND INCENTIVES CODE (LIIC) AND WORKFORCE DEVELOPMENT PLAN (WDP)

The Department of the Interior and Local Government (DILG) XII, through the Local Government Capability Development Division (LGCDD), in partnership with the Bureau of Local Government Development (BLGD) and the Board of Investments (BOI) Davao- Extension, Department of Trade and Industry (DTI) XII, Department of Labor and Employment (DOLE) XII and the Technical Education Skills and Development Authority (TESDA) XII conducted the Training on the Formulation of Local Investment and Incentives Code (LIIC) and Workforce Development Plan (WDP) on June 26-27, 2023 at the Viajera Dine and Café, City of Koronadal, South Cotabato. They then distributed PhilHealth Member Registration Forms (PMRF) and PhilHealth KonSulta Registration Forms (PKRF) and encouraged the participants to register and avail the various benefit packages. Ortiz, CESO V, on behalf of RD Josephine Cabrido-Leysa CESO III, thanked the guests for their time and eagerness to impart and freely share information pertaining to the KonSulTa program, which is highly beneficial to all personnel.
