Recommending the Award of Contract to GENERAL SANTOS REAL HOTEL DEVELOPMENT CORPORATION for the procurement of goods and services (VENUE, MEALS, SNACKS AND ACCOMMODATION) for the "CONDUCT OF THE PROVISION OF TECHNICAL ASSISTANCE ON MAINSTREAMING DRR-CCAM TO THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) ON OCTOBER 14-15, 2021 AND OCTOBER 21-22, 2021" in the amount of One Hundred Sixty Eight Thousand Four Hundred Forty Pesos (Php168,440.00);

WHEREAS, the DILG-XII's Local Government Capability Development Division (LGCDD) is in charge of the prepared and submitted Terms of Reference (TOR) for procurement of goods and services (VENUE, MEALS, SNACKS AND ACCOMMODATION) for the "CONDUCT OF THE PROVISION OF TECHNICAL ASSISTANCE ON MAINSTREAMING DRR-CCAM TO THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) ON OCTOBER 14-15, 2021 AND OCTOBER 21-22, 2021" with an approved budget for the contract (ABC) in the amount of One Hundred Seventy Six Thousand Nine Hundred Pesos (Php 176,900.00);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's annual procurement plan (APP);

WHEREAS, on September 22, 2020 to September 27, 2020, the Invitation to Bid (ITB) was posted to PhilGEPS website for advertisement;

WHEREAS, after the required posting days for advertisement, the bidding failed for the first time because all bidders who submitted their quotations for this item were found to be non-responsive;

WHEREAS, on October 04, 2020 to October 08, 2020, the Invitation to Bid (ITB) was reposted to PhilGEPS website for advertisement;

WHEREAS, after the required posting days for advertisement, the bidding failed for the second time because lone bidder who has submitted a quotation for this item was found to be non-responsive as they were not available on some dates required under the RFQ;
