**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO HILITE MANPOWER AND GENERAL SERVICES FOR THE PROCUREMENT OF JANITORIAL AND ALLIED SERVICES IN THE CONTRACT AMOUNT OF TWO HUNDRED SEVENTY NINE THOUSAND SIX HUNDRED SEVENTY FIVE PESOS (Php279,675.00)**

**WHEREAS**, the expiring one month extension (January 2017) of the contract of services by the agency providing janitorial and allied services for the DILG Regional Office XII was presented for the DILG XII BAC for deliberation;

**WHEREAS**, considering that the DILG XII will require janitorial and allied services from the months of 01 February to 31 December of 2017 or a total of eleven (11) months, a total of Three Hundred Six Thousand Pesos (Php 306,000.00) has been allocated as the approved budget for the contract (ABC);

**WHEREAS**, under Section 53.9, in relation to Section 48.1 of the Revised Implementing Rules and Regulations of Republic Act 9184, provides that *the procuring entity may resort to Small Value Procurement to promote economy and efficiency if the ABC does not exceed Php500,000.00*

**WHEREAS**, on the 16<sup>th</sup> of January 2017 the DILG-XII BAC published the Request for Proposal/Quotation of the said project and that the following suppliers were also invited to submit their proposal/quotations: *1. Baiser Manpower and Allied Services; 2. Virces Janitorial and Allied Services; and 3. Hilite Manpower and General Services;*

**WHEREAS**, the following are the offered proposal/quotation of the interested bidders:

- 1. Virces Janitorial and Allied Services – Php279,675.00*
- 2. Raiser Manpower and Allied Services – Php280,467.00*
- 3. Hilite Manpower and General Services – Php279,675.00*

**WHEREAS**, upon the review and re-assessment of the TWG and group discussion of the BAC members of the DILG XII, the *Hilite Manpower and General Services* was declared as the winning bidder based on the performance rendered for the past nine (9) years;




RESOLVED FURTHER, that a copy of this resolution be forwarded to the Regional Director as Head of the Procuring Entity, for his information and appropriate action.




