Contract Agreement

This **CONTRACT AGREEMENT** executed on the 06th day of February 2017 between the **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT XII (DILG-XII)** (hereinafter called the "Entity" and **SARANGANI HIGHLANDS GARDEN** with business address at Prk. Wal, Brgy. Tambler, General Santos City (hereinafter called the "Supplier"):

WHEREAS, upon request of the Entity, the Supplier submitted a price quotation for the procurement of lease of venue, including accommodations and meals for the conduct of Orientation and Provision of Technical Assistance on the Mainstreaming Conflict-Sensitivity and Peace Promotion (CSPP) and Sectoral Concerns in the Comprehensive Development Plan (CDP) of LGUs in Peace Process Areas Under PAMANA Pillar 1 via Small Value Procurement in the amount of Four Hundred Ninety Six Thousand Six Hundred Forty Pesos (Php 496,640.00) inclusive of all applicable taxes and fees (hereinafter called the "Contract Price"), which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 2017-02-008.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the Revised Implementing Rules and Regulations of RA 9184, viz:
 - (a) The Entity's Request for Quotation dated 01 February 2017, attached as **Annex A**;
 - (b) The Supplier's Proposal dated 04 February 2017, attached as **Annex B**; and
 - (c) The Entity's Notice of Award, attached as **Annex C**.
2. In consideration of the payment to be made by the Entity to the Supplier as hereinbefore mentioned, the Supplier hereby covenants with the Entity to provide the goods, and remedy the defects thereof in conformity with the stipulations of the Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
3. The Entity hereby covenants to pay the Supplier the Contract Price in consideration of the provision of the goods and remedying the defects thereof.
