WHEREAS, in accordance with GPPB Resolution No. 08-2009 "Implementing Guidelines for the Lease of Privately-owned Real Estate and Venue and pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

1. **THE FARM@CARPENTER HILL** – Php 64,500.00 (*See attached TOR*)
2. **VILLA AMOR HOTEL** – Php 64,500.00

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by *Villa Amor Hotel* offers the most advantageous and accessible location for the event and arrangements for DILG;






