BAC Resolution No. 2017-04-017

Recommending the Award of Contract to B-ADS GRAPHICS ICON, CO. for the procurement of Customized Polo Shirt for the use of DILG XII Employees in the Celebration of 2017 National Women's Month in the total amount of Ninety Four Thousand Fifty Pesos (Php 94,050.00)

WHEREAS, the DILG-XII's Local Government Capacity Development Division (LGCDD) is in charge of the prepared and submitted Terms of Reference (TOR) for the procurement of "*Customized Polo Shirt for the use of DILG XII Employees in the Celebration of 2017 National Women's Month*" with an approved budget for the contract (ABC) in the amount of One Hundred Four Thousand Five Hundred Pesos (Php 104,500.00);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency's Annual Procurement Plan (APP);

WHEREAS, after the required posting days for advertisement the following are the offered proposals/quotations of the interested bidders:

1. DRAG-ON PRINTING SOLUTION AND MERCHANDISE – Php 89,870.00
2. B-ADS GRAPHICS ICON, CO. – Php 94,050.00

WHEREAS, in CY 2016, the DILG XII procured GAD uniform/customized polo shirts for DILG XII personnel from the DRAG-ON PRINTING SOLUTION AND MERCHANDISE (the lowest calculated and responsive bidder that time). However, after using the customized polo shirt during the GAD activities, majority of the DILG personnel complained on the quality of the GAD polo shirt;

WHEREAS, due to this experience, for the PROCUREMENT OF CUSTOMIZED POLO SHIRT FOR CY 2017, the RBAC XII carefully examined the quality of the sample GAD customized polo shirts and the bid proposals submitted by the prospective bidders : **DRAG-ON PRINTING SOLUTION AND MERCHANDISE** and **B-ADS GRAPHIC ICON, CO** to avoid recurrence of the same problem;

As a result, the RBAC XII found out that the bid proposal submitted by the next lowest bidder **B-ADS GRAPHICS ICON, CO**, complies with the requirement in our Terms of Reference (TOR), thereby declaring the most responsive bid;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the DILG XII Regional Director/HOPE for his information and appropriate action;




