 Contract Agreement

This CONTRACT AGREEMENT executed on the 12th day of April 2017 between the DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT XII (DILG-XII) (hereinafter called the "Entity" and B-ADS GRAPHICS ICON, CO. with business address at Duremdes Bldg., Gensan Drive, Brgy. Zone I, Koronadal City (hereinafter called the "Supplier"):

WHEREAS, upon request of the Entity, the Supplier submitted a price quotation for the procurement of "Customized Polo Shirt for the use of DILG XII Employees in the Celebration of 2017 National Women's Month" via Small Value Procurement in the amount of Ninety Four Thousand Fifty Pesos (Php 94,050.00 inclusive of all applicable taxes and fees (hereinafter called the "Contract Price"), which the Entity subsequently accepted pursuant to Bids and Awards Committee Resolution No. 2017-04-017.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall form part of this Agreement in accordance with Section 37.2.3 of the Revised Implementing Rules and Regulations of RA 9184, viz:
 - (a) The Entity's Request for Quotation dated 29 March 2017, attached as Annex A;
 - (b) The Supplier's Proposal dated 31 March 2017, attached as Annex B; and
 - (c) The Entity's Notice of Award, attached as Annex C.
2. In consideration of the payment to be made by the Entity to the Supplier as hereinbefore mentioned, the Supplier hereby covenants with the Entity to provide the goods, and remedy the defects thereof in conformity with the stipulations of the Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
3. The Entity hereby covenants to pay the Supplier the Contract Price in consideration of the provision of the goods and remedying the defects thereof.

IN WITNESS WHEREOF, the parties hereto have caused these presents to be signed by their respective duly authorized representatives on the date and place abovementioned.


