WHEREAS, the DILG-XII's Local Government Monitoring and Evaluation Section (LGMES) of the Province of South Cotabato is in charge of the prepared and submitted Terms of Reference (TOR) for the lease of venue, including meals for the conduct of "MASA MASID Orientation for Expanded Ubas Technical Working Group in South Cotabato with an approved budget for the contract (ABC) in the amount of Seventy Two Thousand Four Hundred Fifty Pesos (Php 72,450.00);

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

- 3. Villa Amor Hotel Php 107,870.00
- 4. Cinco Niñas Resto Php 72,450.00
- 5. EMR Entertainment, Music & Recreation Center Php 80,500.00
