WHEREAS, the DILG-XII's Office of the Regional Director (ORD) is in charge of the prepared and submitted Terms of Reference (TOR) for the printing of materials on "*Listong Pamilyang Pilipino in Major River Basin*" with an approved budget for the contract (ABC) in the amount of Five Hundred Fifty Thousand Pesos (Php 550,000.00);

2. Erzalan Printing Press – Php 485,760.00 *Note: The bidder/supplier was disqualified due to the requirements set in the Terms of Reference (TOR). Priority: Within South Cotabato Province only.*
3. St. Anthony Press – *Note: Printer Not Available*
4. Zookee Zookee Custom Prints – *Note: Printer Not Available*

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by *WD Artsign & Gen. Mdse.* is the lowest calculated responsive bid and offers the most advantageous price and arrangements for DILG;
