WHEREAS, on June 14, 2017 before 10:00 A.M. the BAC Secretariat received the Bid Documents of the two (2) Contractors and conduct the eligibility check on the two (2) bid documents (Technical/Financial) using DILG Contract Profile Eligibility Processing (CPEP) from the Civil Works Registry (CWR), and found that the two (2) bidders are compliant to the existing laws, regulations, policies, etc.

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the DILG XII Regional Director for his information and appropriate action;









