Recommending the Award of Contract to AGUA FRIO GARDEN RESORT, INC. for the Lease of Venue, including Meals in the conduct of Orientation on the Management of the Dead and the Missing in the total amount of Fifty Nine Thousand Four Hundred Pesos (Php 59,400.00)

WHEREAS, the DILG-XII's Office of the Regional Director (ORD) is in charge of the prepared and submitted Terms of Reference (TOR) for the lease of venue, including accommodations and meals for the conduct of "Orientation on the Management of the Dead and the Missing" with an approved budget for the contract (ABC) in the amount of Sixty Thousand Pesos (Php 60,000.00);
