Recommending the Award of Contract to FAMILY COUNTRY HOTEL & CONVENTION CENTRE for the Catering Services and Room Accommodation in the conduct of Regional Project Monitoring Evaluation System (RPMES) Relative to the Implementation of Locally Funded Projects (LFPs) in the total amount of One Hundred Seventeen Thousand Nine Hundred Pesos (Php 117,900.00)

WHEREAS, the DILG-XII's Office of the Regional Director (ORD) – Project Development Monitoring Unit (PDMU) is in charge of the prepared and submitted Terms of Reference (TOR) for procurement of meals and room accommodation for the conduct of *“Regional Project Monitoring Evaluation System (RPMES) Relative to the Implementation of Locally Funded Projects (LFPs)”* with an approved budget for the contract (ABC) in the amount of One Hundred Forty One Thousand Pesos (Php 141,000.00);

WHEREAS, Sec. 48, Rule XVI of the Revised IRR (RIRR) of R.A. 9184, otherwise known as the “Government Procurement Reform Act” provides that in order to promote economy and efficiency and obtain the most advantageous price for the government, the procuring entity may resort to any of the alternative methods of procurement, provided it is reflected in the agency’s annual procurement plan (APP);

WHEREAS, in accordance with GPPB Resolution No. 13-2016 dated August 9, 2016 “Implementing Guidelines for Small Value Procurement pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

- 1. DOLORES TROPICANA RESORT – Php 90,000.00**
- 2. FAMILY COUNTRY HOTEL & CONVENTION CENTRE – Php 117,900.00**

WHEREAS, on June 28, 2017, Dolores Tropicana Resort, the lowest calculated bidder sent a Letter of Refusal because they can no longer accommodate the activity;

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by
