Recommending the Award of Contract to VILLA AMOR HOTEL for the procurement of Meals and Accommodation in the conduct of Batch 3 – Training-Orientation on Regional Project Monitoring Evaluation System (RPMES) Relative to the Implementation of Locally Funded Projects (LFPs) in Koronadal City in the total amount of One Hundred Forty Seven Thousand Two Hundred Pesos (Php 147,200.00)

WHEREAS, the DILG-XII's Office of the Regional Director (ORD) – Project Development Monitoring Unit (PDMU) is in charge of the prepared and submitted Terms of Reference (TOR) for the procurement of meals and accommodation for the conduct of *Batch 3 – Training-Orientation on Regional Project Monitoring Evaluation System (RPMES) Relative to the Implementation of Locally Funded Projects (LFPs) in Koronadal City* with an approved budget for the contract (ABC) in the amount of One Hundred Fifty Thousand Four Hundred Pesos (Php 150,400.00);

WHEREAS, in accordance with GPPB Resolution No. 08-2009 “Implementing Guidelines for the Lease of Privately-owned Real Estate and Venue and pursuant to Section 53.9 of the RIRR of RA9184, Request for Quotation (RFQ) for the said activity has been posted in the PhilGEPS.

WHEREAS, after the required posting days for advertisement are the offered proposal/quotation of the interested bidders:

1. THE FARM@CARPENTER HILL– Php 150,400.00
2. VILLA AMOR HOTEL – Php 147,200.00
3. CINCO NIÑAS RESTO – Php 170,880.00

WHEREAS, after careful evaluation of the bids submitted by the bidders and upon review by due diligence of their compliance to the technical specifications of the project, the Bids and Awards Committee found that the proposal/price quotation submitted by *Villa Amor Hotel*, the lowest calculated responsive bid and offers the most advantageous price and arrangements for DILG;
