COMMEMORATION OF THE NATIONAL DAY FOR YOUTH IN CLIMATE ACTION AND THE ASEAN YOUTH IN CLIMATE ACTION AND DISASTER RESILIENCE DAY ON NOVEMBER 25, 2020

Pursuant to Proclamation No. 1160, the National Youth Commission (NYC), together with its institutional partners, the Department of Environment and Natural Resources (DENR), Climate Change Commission (CCC), and the United Nations Children's Fund (UNICEF), among others, is spearheading the observance of the "National Day for Youth in Climate Action" on November 25, 2020.
