**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the Joint RIATF-EID XII- RTF-COVID-19 approved the following Resolutions:

- RESOLUTION REQUESTING THE LAW ENFORCEMENT AUTHORITIES TO CONDUCT SCANNING OF RCCTS ID IN ALL BORDERS OF REGION XII;
- RESOLUTION BANNING THE PHYSICAL CAROLING REGIONWIDE FOR CY 2020, SUBJECT TO THE DISCRETION OF THE LGUs AND THE SUBSEQUENT GUIDELINES OF THE IATF-EID;
- RESOLUTION URGING ALL POVINICIAL LGUS TO LEAD IN THE ORGANIZATION OF THE ONE HOSPITAL COMMAND;
- RESOLUTION ENJOINING LGUs THAT ARE CONDUCTING SERBISYO CARAVANS AND OTHER MASS GATHERINGS TO STRICTLY IMPLEMENT THE HEALTH PROTOCOLS AND TO ENACT ORDINANCES TO CONTAIN THE SPREADING OF THE VIRUS; AND
- RESOLUTION URGING LGUs OF REGION XII TO ENACT AN ORDINANCE SUPPORTING THE BIDA CAMPAIGN OF THE NATIONAL GOVERNMENT
