RESOLUTION NO. 2021-19A

RESOLUTION ENJOINING ALL LGUS OF REGION XII TO IMMEDIATELY ESTABLISH VAXCERTPH BOOTH AND DESIGNATE PERSONNEL OR POINT PERSON TO REGULARLY MANAGE THE VAXCERTPH PORTAL

WHEREAS.

Republic Act No. 11525, also known as the COVID-19 Vaccination Program Act of 2021 mandates DOH through the LGUs and other key offices, to issue COVID-19 vaccine cards to all persons vaccinated in the Philippines, subject to the provisions of RA 10173 or the "Data Privacy Act of 2012". DOH in coordination with DICT was mandated to develop digital systems and applications which will provide uniform vaccine cards consistent with and acceptable to international standards;

WHEREAS,

DICT has developed a digital verification process of vaccination known as **VaxCertPh** sometime in August 2021; the application is a self-service portal that pulls immunization data from a line list record submitted by local government units and stored in a VIMS database;



WHEREAS,

DILG Memorandum Circular No. 2021-095 enjoins the Local Government Units, being at the frontline in the implementation of vaccination program, to establish at least one (1) VaxCertPH booth to provide means to vaccinated individuals with little to no technological access/knowledge in generating their Digital Vaccination Cards (DVCs), as well as perform the validation and rectification process. Further, they are mandated to provide manpower resources (VaxCertPh Designate/Point Person) responsible to generate DVCs to booth-goers, assist in the validation and rectification of incorrect or no record found cases, and coordinate with Contact Centers regarding the status of submitted requests:

WHEREAS,

the operationalization of VaxCertPH in all LGUs will track the progress of the government's vaccination program and ensure the issuance of trusted, verifiable and internationally-recognized proof of vaccination to Filipinos;

NOW THEREFORE, on motion of ARD Flora P. Gabunales, CESO V of DTI XII, and seconded by RD Macario D. Gonzaga of LTO XII; BE IT RESOLVED, as it is hereby RESOLVED, to Enjoin All LGUs of Region XII to Immediately Establish VaxCertPH Booth and Designate Personnel or Point Person to Regularly Manage the VaxCertPH Portal;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information and support. The same copy shall be furnished to all Local Government Units of Region XII for their information and appropriate action.
