RESOLUTION NO. 2021-26A

November 17, 2021

RESOLUTION URGING THE LOCAL GOVERNMENT UNITS OF REGION XII TO RAMP-UP THE COVID-19 VACCINATION CAMPAIGN TO REACH AT LEAST 70% OR HERD IMMUNITY OF THEIR RESPECTIVE ELIGIBLE POPULATION (12-YEAR-OLD AND ABOVE) BY END OF DECEMBER 2021

WHEREAS,

per report of the DOH-CHD XII, Region XII is in the 7th rank among Regions with highest number of unvaccinated eligible population from November 13, 2021 to November 17, 2021. Region XII ranks No. 12 in terms of the total vaccination counts in the entire country which indicates that only 38% of the population have been vaccinated with at least one dose while 25.5% are fully vaccinated;

WHEREAS.

per monitoring of DOH-CHD XII in the preparation for the National Vaccination Days, Region XII only reached 48.05% to include the projection of vaccination team requirements, number of existing and needed vaccination teams, and number of existing and needed vaccination sites and availability of vaccines for all eligible population of the country including the 12-year-olds;

WHEREAS

the Body recognizes that the local government units of Region XII thru its Local Chief Executives need to ensure that advocacy, social mobilization, logistical support, functionality of vaccination teams and sites, and monitoring of vaccination activities are in-placed, for a systematic and strategic vaccination implementation within their territorial jurisdictions, towards the achievement of herd immunity by December 2021;

NOW THEREFORE, on motion of RD Macario D. Gonzaga of LTO XII and seconded by Atty. Felix S. Alicer of DENR-XII; BE IT RESOLVED, as it is hereby RESOLVED, to urge the local government units of Region XII to ramp-up the COVID-19 Vaccination Campaign to reach at least 70% of herd immunity of their respective eligible population (12-year-old and above) by end of December 2021;

RESOLVED FURTHER, that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information. The same copy shall also be furnished to all Regional Line Agencies of Region XII for their information and appropriate action.
