**RESOLUTION NO. 2021-30** December 9, 2021

RESOLUTION COMMENDING GENERAL SANTOS CITY FOR BEING IDENTIFIED AS THE MOST IMPROVED AND HAS THE HIGHEST CUMULATIVE NUMBER OF ADMINISTERED VACCINES DURING THE 3-DAY NATIONAL COVID-19 VACCINATION DAYS



- WHEREAS, the "Bayanihan, Bakunahan" National Task Force Against COVID-19 (NTF) recognized the top performing local government units (LGUs) around the country for their outstanding contribution on the first round of the government's three-day National COVID-19 Vaccination Days in its culmination day on December 9, 2021;
- WHEREAS, tagged by the DOH as one of the high-risk areas with low vaccination performance, the City of General Santos also has the highest number of COVID-19 cases in Region XII and has imposed intensified border lockdowns, "No Movement Sunday", liquor ban, and other strict movement restrictions at the height of infection periods;
- WHEREAS, with the goal to bring the City to herd immunity status and re-open its economy, the City Government of General Santos has stepped up in its inoculation activities through "massive" vaccination of eligible population during the 3-day National COVID-19 Vaccination Days on November 29, 30, and December 1, 2021; Hence, one of the LGUs that was recognized by the National Task Force as the most improved and highest number of cumulative jabs.
- **WHEREAS,** the Body recognized the commendable effort of the City Government of General Santos in stepping up its COVID-19 vaccination efforts with the support of its component barangays, the private sector, and all stakeholders that jointly contributed in reaching a high number of cumulative jabs in just three (3) days;
- NOW THEREFORE, on motion of RD Jeany T. Tedera of DOF-BLGF XII and seconded by RD Akmad J. Usman of DBM XII; BE IT RESOLVED, as it is hereby RESOLVED, to commend General Santos City being one of the LGUs that has the most improved and highest cumulative number of administered vaccines during the 3-day National COVID-19 Vaccination Days;
