**RESOLUTION NO. 2021-31**

**RESOLUTION ADOPTING THE ONE REGIONAL STRATEGY FOR COVID-19 MANAGEMENT AND RESPONSE (*Isang Rehiyon Dose, Laban sa Pandemya*) FOR REGION XII**





**WHEREAS,** Section 15 Article II of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS,** on March 8, 2020, President Rodrigo R. Duterte issued Proclamation No. 922 series of 2020, declaring a state of public health emergency throughout the country due to the COVID-19 outbreak posing a threat to national security;

**WHEREAS** in cognizance with the imminent threat of the COVID-19 virus to the Region, there is a need to establish policies, guidelines, and mechanisms pertaining to the movement of goods and people, imposition of curfew hours, establishment and operations of checkpoints, implementation of community quarantines, aggressive case finding, contact tracing, among others;

**WHEREAS** following the Presidential Proclamation, on March 18, 2020, the Regional Task Force Against COVID-19 was created by virtue of the Joint RPOC XII and RDRRMC XII Resolution No. 2020-05 to address COVID-19 issues affecting the Region such as creating policies on complementation of resources between and among local government units of Region XII, uniformity in the implementation of community quarantine, "Hatid Tulong" and "Sundo" initiatives for OFWs and locally-stranded individuals, regional contact tracing system, uniform guidelines in relation to movement of persons and goods, unified vaccination program implementation, among many others;

**WHEREAS** the body unanimously agreed to adopt a "One Regional Strategy for COVID-19 response: *Isang Rehiyon Dose, Laban sa Pandemya*" as a strategy to implement a region wide unified effort and coordinated actions in safeguarding the health and safety of the constituents of Region XII;

**NOW THEREFORE,** on motion of RD Akmad J. Usman of DBM XII and seconded by ARD Jerome S. Barranco of OCD XII; **BE IT RESOLVED,** as it is hereby **RESOLVED,** to adopt a "One Regional Strategy for COVID-19 response: *Isang Rehiyon Dose, Laban sa Pandemya*" for Region XII;

**RESOLVED FURTHER,** that a copy of this Resolution be forwarded to the IATF-EID, NTF COVID-19, and members of RIATF-EID XII and RTF-COVID-19 XII for their information. Same Resolution be forwarded to all members of the RIATF-EID XII and RTF-COVID-19 XII and all local government units of Region XII for their information and support.
