## **RESOLUTION NO. 2022-08**

January 12, 2022

RESOLUTION REITERATING THE SUBMISSION OF SAFETY SEAL APPLICATION FOR REGIONAL LINE AGENCIES (RLAS) UNTIL MARCH 31, 2022

WHEREAS, Section 15 Article II of the 1987 Constitution provides that the State shall

protect and promote the right to health of the people and instill health

consciousness among them;

WHEREAS, IATF-MEID has released Resolution No. 87 dated December 3, 2020 adopting the

implementation of the Safety Seal Certification Program which requires all establishments (i.e. government offices, private companies, hotels, and business

establishments) and public transportation units to adopt the Safety Seal;

WHEREAS, DOLE, DOH, DILG, DOT and DTI issued Joint Memorandum Circular No. 21-01

which sets the guidelines of the Safety Seal Certification Program. It delineates

the coverage of the agencies involved as issuing authorities of the Safety Seal;

WHEREAS, DILG issued Memorandum Circular No. 53 dated May 12, 2021 provides for the implementing guidelines of the Safety Seal Certification Program for the

Department and the LGUs as Issuing Authorities. The RIATF-EID XII and RTF on

COVID-19 XII in adherence to DILG MC No. 53, believes that with the gradual resumption of full workload operation among many NGAs, the minimum health

protocols in the workplace should be strictly observed at all times to prevent COVID-19 transmission in the offices and household members of the APORs;

WHEREAS,

there are only eleven (11) Regional Offices issued with Safety Seal by the Inter-Agency Certification and Inspection Team from October 27, 2021- January 6, 2022; The Safety Seal Inter-Agency Certification and Inspection Team has recommended to extend the deadline to provide time for the Regional Offices to comply with the requirements of the Joint Regional Memorandum Circular;

NOW THEREFORE, on motion of ARD Flora Gabunales of DTI XII and seconded by RD TERESITA SOCCORO C. RAMOS of NEDA XII; BE IT RESOLVED, as it is hereby RESOLVED, to REITERATE THE SUBMISSION OF SAFETY SEAL APPLICATION FOR REGIONAL LINE AGENCIES (RLAS) UNTIL MARCH 31, 2022.
