RESOLUTION NO. 2020-023-B

July 29, 2020

RESOLUTION ADOPTING A SCHEDULED COMMERCIAL FLIGHT IN GENERAL SANTOS CITY INTERNATIONAL AIRPORT TRANSPORTING LSIS EVERY 15 DAYS TO TAKE EFFECT ON AUGUST 06, 2020

WHEREAS, Per OMNIBUS GUIDELINES ON THE IMPLEMENTATION OF COMMUNITY QUARANTINE IN THE PHILIPPINES *with Amendments as of July 16, 2020*, the IATF approved the Implementation of the Modified Enhanced Community Quarantine (MECQ) including the zoning concept, corresponding qualification, and its phased response or intervention;

As of July 29, 2020, Region 12 is still under MGCQ status, hence, the following provisions under the Omnibus Guidelines shall be strictly observed, to wit:

- Minimum public health standards shall be complied with at all times for the duration of the MGCQ;

- The movement of all persons in areas placed under MGCQ shall be limited to accessing essential goods and services, for work in the offices or industries permitted to operate hereunder, and for other activities permitted under this Section. *(As amended by Paragraph A(4)(a) of IATF Resolution No. 43, June 03, 2020);*

WHEREAS, the Hatid Tulong Initiative is a transportation assistance program intended to help stranded people affected by the COVID-19 lockdown to return to their home provinces. The Hatid Tulong Program targets those who left their home provinces hoping to land jobs elsewhere, including Metro Manila, but ended up as informal settlers. The government is looking at a period of 2 to 3 months to transport all remaining 13,000 locally-stranded individuals;

However, LCEs observed that there are LSIs who did not avail of the Hatid Tulong Initiative of the government but instead opted to travel back home via Commercial Flights. Thus, causing the profiling and contact tracing difficult for the authorities;

WHEREAS, as of July 28, 2020, Region 12 has a total of 235 confirmed COVID-19 cases. The increase of COVID-19 cases in the Region has been attributed to the implementation of Hatid Tulong Program for LSIs and ROFs and those that travelled via Commercial Flights. For the month of July 2020, Region 12 recorded an average increase of 5 cases per day.

WHEREAS, with the increasing trend of COVID 19 cases in the region, there are LCEs that raised their concerns regarding the capacity of health care systems of some LGUs, more specifically on the availability of contact tracers, and temporary treatment monitoring facilities (TTMFs);

WHEREAS, after thorough deliberation, the Body agreed to brought the concern to appropriate authorities and request for a scheduled commercial flight in General Santos City International Airport to avoid the further spreading of the virus given the foregoing premises;


NOW, THEREFORE, on motion of RD TERESITA SOCORRO RAMOS of NEDA XII and duly seconded by RD ALLAN G. FARNAZO, CESO IV, of DEPED XII and RD MACARIO D. GONZAGA of LTO XII; **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to *ADOPT A SCHEDULED COMMERCIAL FLIGHT IN GENERAL SANTOS CITY INTERNATIONAL AIRPORT TRANSPORTING LSIS EVERY 15 DAYS TO TAKE EFFECT ON AUGUST 06, 2020*


RESOLVED FURTHER, that a copy of this Resolution be forwarded to the DoTR Secretary Arthur P. Tugade, National IATF-EID and NTF COVID-19 for their consideration and appropriate action. The same copy to be furnished to the members of the RIATF-EID XII & RTF COVID-19, Provincial Governors, City and Municipal Mayors of Region XII for their information and reference.


