A RESOLUTION REQUESTING LGUs OF R12 TO READILY IDENTIFY POTENTIAL ACCOMMODATION ESTABLISHMENTS IN THEIR AOR AS QUARANTINE FACILITIES FOR OFWs UNDER RA 11469 AND TO SUBMIT THE SAME TO DILG 12

WHEREAS, RA 11469 or the Bayanihan to Heal as One Act provides authority to the President to direct the operations of privately-owned establishment; provided, that the management and operation thereof shall be retained by the owners of the enterprise; and provided, further, that if the said enterprise unjustifiably refuse or signify they are no longer capable of operating their establishment, the President may take over their operations subject to the limits under the Constitution. It also provides that the President may require businesses to prioritize and accept contracts, subject to fair and reasonable terms, for services necessary to mitigate, if not contain, the transmission of COVID-19;

WHEREAS, Joint DOH-DOT-DILG Administrative Order No. 2020-01 dated April 3, 2020 was issued providing for the guidelines on the operations of accommodation establishments as quarantine facilities for OFWs under RA 11469;

WHEREAS, Section 4 of the said Order provides that the DOT and DILG shall jointly identify DOT-accredited and Non-Accredited establishments in each region that may potentially be used as Quarantine Facilities. Also, ***DILG shall require LGUs to submit a list of enterprises that have been issued Mayor's or Business Permits to operate as Accommodation Enterprises;***

WHEREFORE, upon motion of RD Josephine Cabrido-Leysa, CESO III of DILG 12, and duly seconded by RD Aristides Concepcion-Tan, MD, MPH, CESO III of DOH-CHD 12;

RESOLVE AS IT IS HEREBY RESOLVED, to REQUEST LOCAL GOVERNMENT UNITS (LGUs) OF REGION 12 TO READILY IDENTIFY POTENTIAL ACCOMMODATION ESTABLISHMENTS IN THEIR AOR AS QUARANTINE FACILITIES FOR OFWs UNDER RA 11469 AND TO SUBMIT THE SAME TO DILG 12;

RESOLVED FURTHER, that a copy of this Resolution be furnished to Hon. Eduardo M. Ano, DILG Secretary, the Regional IATG Members, the Regional Task Force on CoVID-19 Members, the Management of the Dead and Missing Cluster members, and the local government units within the region for their information and appropriate action.


