## INVITATION TO BID FOR MEDICAL SUPPLIES, DRUGS AND MEDICINES FOR THE SUPPORT TO COVID-19 CONTACT TRACING OPERATIONS OF DILG XII

- 1. The Department of the Interior of Local Government Region XII, through REPUBLIC ACT 11518 intends to apply the sum of One Million Four Hundred Seventy Eight Thousand and Seven Hundred Fifty Pesos Only (PHP 1, 478, 750.00) being the ABC to payments under the contract for MEDICAL SUPPLIES, DRUGS AND MEDICINES FOR THE SUPPORT TO COVID-19 CONTACT TRACING OPERATIONS OF DILG XII. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of the Interior of Local Government Region XII now invites bids for the above Procurement Project. Delivery of the Goods is required not later than TWENTY (20) CALENDAR DAYS including Saturdays, Sundays, and Holidays from the receipt of Notice to Proceed (NTP). Bidders should have completed, within the prescribed period from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Under Section 23.4.1.2 of the 2016 revised IRR of RA No. 9184 do not exist:] Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
  - BIDDING IS OPEN TO ALL QUALIFIED BIDDERS, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

- 4. Prospective Bidders may obtain further information from the Department of the Interior and Local Government (DILG) Region XII through its Regional Bids and Awards Committee (RBAC) from 8:00 AM to 5:00 PM (Monday Friday) excluding Saturdays, Sundays, and Holidays.
